#### IFIP community activities, achievements and possibilities for your Society

IFIP was represented by VP Jacques Sakarovitch and General Secretary Anatolii Marushchak. IFIP extends our congratulations to Francis Baud, President of the Swiss Informatics Society (SI) on his re-election in May 2024.

On 26-27 March 2024, the <u>IFIP Board met in Toronto</u>, Canada, hosted by the Canadian Information Processing Society (CIPS) - Canada's Association of IT Professionals. IFIP and President Anthony Wong acknowledged and expressed warmest thanks and gratitude to CIPS and the Chair of the CIPS National Board, Trevor McDonald, CEO Greg Lane, COO Mary Jean and IFIP CIPS representative Margaret Havey for their hospitality and for hosting IFIP.

CIPS also hosted a <u>Joint Working Session</u> with IFIP and the Chair of IFIP's Task Force on Climate Change, Raimundo Macedo on: "How can IT be used to address societal issues especially as regards to the environment and global warming? Raimundo Macedo provided an overview of the Task Force initial findings, after which attendees had the opportunity to present their respective countries' top three initiatives on climate change. The IFIP Task Force is exploring challenges and opportunities in using digital technologies to combat climate change and its impacts, in alignment with the United Nations Sustainable Development Goals.

### IFIP Digital Equity Committee (DEC)

The IFIP Digital Equity Committee (DEC) has a new Charter, chaired by Past President Leon Strous. Some of DEC's activities include:

- Initiating the development of and/or create a framework for IFIP doctoral consortia/webinars. A particular emphasis will be on benefits for young researchers and professionals from developing and emerging countries.
- Acting as a promotor of IFIP doctoral consortia / webinars and other activities focussing on enabling the participation of young researchers and young professionals from developing and emerging countries and/or underprivileged communities.
- Acting as a coordinating committee that identifies programs / activities of UN agencies in relation to digital equity and sustainable development with potential for IFIP participation.
- Engaging with IFIP bodies and IFIP member societies to encourage and initiate activities / events aimed at achieving digital equity and sustainable development.
- Providing assistance for the effective operations of ICT societies in general, including non-IFIP members, to strengthen their effectiveness in achieving digital equity and sustainable development.

#### **IFIP Awards**

<u>Nominations</u> are open until 15 June 2024. Nominations for the Auerbach and Service awards can only be made by General Assembly members through the secure area. <u>Nomination for Fellowships</u> can be submitted by anyone, except the person

nominated or members of the Fellow Selection Committee. Nominations must also include details of five referees who must be current members of an IFIP Working Group, Technical Committee or the General Assembly.

### **IFIP and UN Agencies**

IFIP is recognized by the United Nations and other world bodies, with consultative status with the UN Economic and Social Council (ECOSOC), UNESCO, and ITU. IFIP is a supporting partner of the World Summit on the Information Society (WSIS) and collaborates with the UN Commission on Science and Technology for Development (CSTD) and with UNIDO.

Our Congratulations to the Ambassador of Gambia to Switzerland & to the UN Organisations at Geneva, H.E. <u>Amb.Prof.Muhammadou M.O. Kah, Ph.D</u> on his <u>appointment</u> as the Chair of the United Nations Commission on Science and Technology for Development (CSTD) at the 27th Session of the United Nations Commission on Science and Technology for Development (CSTD) held recently at the Palais des Nations in Geneva.

Ambassador Kah is an Extraordinary Diplomat, Academic, Technologist and Banker. He has served as Vice Chair for Africa at the UN Human Rights Council (UNHRC) and previously held the position of Vice Chair of <u>CSTD</u>. Professor Kah has also held significant roles, including as Chair of the African Group of Ambassadors in Geneva, Vice Chair at the WIPO General Assembly and have also been involved in several IFIP Technical Committees and Working Groups. We extend our warmest congratulations to <u>Amb.Prof.Muhammadou M.O. Kah, Ph.D</u>.

Some of IFIP's activities with the UN agencies include:

- A MoU with the ITU (International Telecommunications Union) AI for Good program to increase its scale and impact.
- IFIP partnered with the Internet Governance Forum (IGF) and the UN Commission on Science and Technology for Development (CSTD) in Addis Ababa, Ethiopia. IFIP President Anthony Wong introduced and moderated a panel session, which explored issues relating to "Ethics and Regulation of Emerging Technologies and Artificial Intelligence".
- IFIP President addressed the 26th Session of the United Nations Commission on Science and Technology for Development (CSTD) at the Palais des Nations in Geneva.
- In cooperation with UNESCO and ACS, IFIP President Anthony Wong organised and moderated a recent global webinar on the use of Indigenous data, art and materials by Generative AI.
- ACM Fellow, former BCS President, and Co-Chair of the ACM Publications Board, Dame Wendy Hall was nominated to the UN AI Advisory Board.
- Professor Don Passey, chair of TC 3 (Education) participated in the UNESCO Paris discussion on "Concerning Education for International Understanding, Co-operation and Peace, and Education relating to Human Rights and Fundamental Freedoms".
- Past President Leon Strous participated in the meeting of the UNESCO's Intergovernmental Council for the Information for all Programme (IFAP).

 IFIP General Secretary, Professor Anatolii Marushchak participated in a discussion at the United Nations Industrial Development Organization (UNIDO) "Inclusive AI – Bridging the Digital Divide in Industry and Manufacturing".

## WSIS 2024

IFIP have contributed to the World Summit for Information Society (WSIS) over many years including formal recognition as a "Supporting Partner". WSIS is co-organized by ITU, UNESCO, UNDP, UNCTAD and the Swiss Confederation.

A team from IFIP will once again participate at the hybrid WSIS:

- IP3 <u>session</u> "Re" Generative AI Using Artificial and Human Intelligence in tandem for innovation" on 28 May 2024.
- TC11 event "Building confidence and security in connected IT systems" on May 29 2024.
- IFIP President invited to participate in the UNESCO panel on "The Future of Al in the Judiciary" on May 29 2024.
- <u>UNESCO panel</u> on on the importance of promoting universal access to information and knowledge on May 29 2024.
- TC12 <u>panel discussion</u> on "Synergy Human-Al for complex problemsolving" on May 30 2024.
- IFIP President invited to participate in the UNESCO <u>panel</u> WSIS Action Line C7 "E-science: Assessment of progress made over the last 20 years" on May 30 2024.

# Other IFIP news.

- IFIP IP3 completed the reaccreditation of two national societies, ACS (Australian Computer Society) and IPSJ (Information Processing Society of Japan).
- IFIP President Anthony Wong met with the Presidents of IFIP Member, Danish Federation for Information Processing (DANFIP), CEPIS, Brazilian Computing Society, Swiss Informatics Society, ACM President Yannis Ioannidis, to discuss mutual collaborations.
- The Slovak Society for Computer Science successfully applied for external financial support to cover expenditures on hosting General Assembly 2023.
- The Australian Computer Society hosted the IFIP Strategy Day at the offices of the ACS in Barangaroo in Sydney, Australia in April 2023.
- IFIP President Anthony Wong and General Secretary Anatolii Marushchak met with The International Institute for Applied Systems Analysis (IIASA) and the International Federation of Automatic Control (IFAC) in Laxenburg, Austria to discuss future collaborations.

- IFIP Task Force on the Climate Change and Digital Technology developing its report to be presented in 2024.
- IFIP is developing cooperation with Association for Information Systems Association (aisnet.org).
- IFIP is developing collaboration with Heidelberg Laureate Foundation. Each year 200 selected young researchers from all over the world are sponsored to spend a week in Heidelberg interacting and networking to encourage scientific exchange with recipients of the most prestigious awards in mathematics and computer science, including the Abel Prize, ACM A.M. Turing Award, and ACM Prize in Computing.

The other IFIP Member Society, the Institute of Information Technology Professionals South Africa, for instance, is focusing its efforts on addressing the gender imbalance in the IT sector and is <u>stepping</u> up the work of its Women in IT (WIIT) Chapter in line with this.
- 7. Your Society can access and contribute to a wealth of information held in <u>IFIP</u> <u>Digital Library</u>, for instance, applying for an open access projects funding.
- 8. The discount for participation in IFIP events is at least 10% on registration fees for all individual members of your Society.
- 9. The possibility of publishing in Springer publications which is a great benefit for individual members of your Society pursuing their academic career.
